SPECIAL NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN
READ THIS FORM COMPLETELY AND CAREFULLY.

YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF MAGNOLIA DUNES, LLC USES REASONABLE CARE IN PROVIDING THIS ACTIVITY, THERE IS A CHANCE YOUR CHILD MAY BE SERIOUSLY INJURED OR KILLED BY PARTICIPATING IN THIS ACTIVITY BECAUSE THERE ARE CERTAIN DANGERS INHERENT IN THE ACTIVITY WHICH CANNOT BE AVOIDED OR ELIMINATED.

YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND MAGNOLIA DUNES, LLC HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.

PARENTS AND GUARDIANS MUST SIGN A DIFFERENT SEPARATE FORM -- COMPLETE LIABILITY RELEASE – CONTRACT OF RELEASE AND WAIVER, ASSUMPTION OF RISK, AND INDEMNIFICATION.

SIGNING THIS FORM DOES NOT DIMINISH THE COMPLETE LIABILITY WAIVER RELEASE THAT ANY NATURAL GUARDIAN OR OTHER PERSON OVER THE AGE OF 18 HAS SIGNED. ANY DIFFERENCE IN LIABILITY WAIVED IS ONLY FOR MINORS AS PRESCRIBED BY FLORIDA LAW (744.301 FS).
